
Fee to Trust Resolution for the Former Delores Smits Property

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has be delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe has acquired in fee status the following parcel described as: Former Delores Smits property located at 249 Valley Road, 2793 S. Overland Road, 2700 Block S. Overland Road, 200-300 Blocks Florist Drive, 400 Block Airport Dr. and
- WHEREAS,** the parcel is described as follows:

- WHEREAS,** the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide existing agricultural, residential, Tribal Offices/Programs, and
- WHEREAS,** the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

A parcel of land located in part of Indian Claims One Hundred Thirty-seven (137), One Hundred Thirty-eight (138), One Hundred Forty-eight (148), One Hundred Forty-nine (149) and One Hundred Fifty (150), also part of Government Lot One (1) and part of the Southeast Quarter of the Southeast Quarter (SE 1/4 of SE 1/4), in Section Three (3), Township Twenty-Three (23) North, Range Nineteen (19) East of the Fourth Principal Meridian, in the Town of Hobart, Brown County, Wisconsin, more fully described as follows:

"172", also known as Airport Drive; thence S82°01'34"E, 84.00 feet along said right-of-way; thence S 89°41'18"E, 18.89 feet along said right-of-way; thence 41.16 feet along said right-of-way being the arc of a 1482.40 foot radius curve to the left whose long chord bears S79°14'17"E, 41.16 feet; thence S32°40'12"W, 271.93 feet along the intended westerly line of Jacket 12857, Image 35, as occupied; thence S63°50'36"E, 131.22 feet along the intended southerly line of said Jacket 12857, Image 35, as occupied; thence N29°03'46"E, 309.54 feet along the intended easterly line of said Jacket 12857, Image 35, as occupied, to the southerly right-of-way of S.T.H. "172", also known as Airport Drive; thence 177.52 feet along said right-of-way, being the arc of a 1482.40 foot radius curve to the left whose long chord bears S88°11'51"E, 177.42 feet along said right-of-way; thence N88°22'19"E, 454.96 feet along said right-of-way; thence S45°39'07"E, 55.53 feet along said right-of-way; thence S0°19'28"W, 2549.31 feet along the westerly right-of-way of Overland Road; thence S89°33'05"W, 287.03 feet along the northerly line of Jacket 8144, Image 24; thence S0°19'28"W, 403.04 feet along the westerly line of said Jacket 8144, Image 24; thence N89°33'05"E, 287.03 feet along the southerly line of said Jacket 8144, Image 24, to the westerly right-of-way of Overland Road; thence S0°19'28"W, 916.96 feet along said westerly right-of-way to the south line of Section 3, Township 23 North, Range 19 East, being the centerline of Florist Drive; thence S89°33'19"W, 1281.64 feet along said Section line and said centerline to the point of beginning.
