



RESOLUTION # 5-4-94-A

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the growth of the Oneida Tribe in the areas of economic, community, and enterprise development warrants skilled tradespeople for this development, and

WHEREAS, the growth of the Oneida Tribe must include the growth and development of our human resources in preparation for apprenticeable trades and the opportunities for individuals to train for jobs that pay higher wages, and carry transferrable lifelong skills, and

WHEREAS, an apprenticeship program will provide new employment and training opportunities to community members, and

WHEREAS, the Interim Oneida Apprenticeship Committee has been established to address the need for an apprenticeship program and develop operating guidelines for implementation, and

NOW THEREFORE BE IT RESOLVED: the Interim Oneida Apprenticeship Committee will seek certification for the Standards of Apprenticeship for the Oneida Nation of Wisconsin Apprenticeship Program through the United States Department of Labor, Bureau of Apprenticeship and Training.

BE IT FURTHER RESOLVED: that once the Oneida Nation of Wisconsin Apprenticeship Program is certified by the United States Department of Labor, Bureau of Apprenticeship and Training, the newly appointed Oneida Nation Joint Apprenticeship Commission will take the place of the Interim Oneida Apprenticeship Committee after a three month training and transition period.

BE IT FURTHER RESOLVED: that when the aforementioned criteria have been met, the Interim Oneida Apprenticeship Committee will dissolve with their duties being transferred to the formally appointed Oneida Tribe Joint Apprenticeship Commission which will be recognized by the Oneida Business Committee as a formal operating body consisting of the nine people with the authority to use the goals of the Oneida Tribe in the further development and operation of an Apprenticeship Program.

BE IT FINALLY RESOLVED: that the Oneida Business Committee hereby recognizes the Oneida Nation Joint Apprenticeship Commission who will operate the Oneida Nation of Wisconsin Apprenticeship Program, follow and improve the guidelines for the operation of the Commission, and further develop comprehensive training plans for many trades.
