

RESOLUTION # 5-11-94-C

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Erma Danforth are holders of lease no. B-675(72), described as follows:

A parcel of land in the SW 1/4 SW 1/4, Section 10, Township 24 North, Range 19 East, 4th P.M., Wisconsin, more particularly described as follows: Beginning at the Southwest corner of Section 10, thence from said initial point by metes and bounds, North on the section line, 330 feet; thence East 264 feet; thence South 330 feet, to a point on the South section line of said Section 10; thence West on the Section line, 264 feet to the place of beginning, containing 2.0 acres, more or less, subject to valid existing rights-of-way of record.

WHEREAS, Erma Danforth, holders of lease no. B-675(72) no longer intend to use said lease site.

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee in  $\underline{Kegulan}$ Session assembled, hereby approves the \*CANCELLATION of lease no. B-675(72)

BE IT FURTHER RESOLVED, that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease \*CANCELLATION documents for and in behalf of the Oneida Tribe of Indians of Wisconsin.
