RESOLUTION NO. <u>5-15-91- H</u>

WHEREAS, The Oneida Tribal Council has delegated to the Oneida Business Committee authority to exercise the enumerated powers of the Oneida Constitution, Article IV as amended, and

WHEREAS, The Oneida Tribe has acquired in fee status the following parcel described as:

Parts of the Southwest 1/4-Northwest 1/4, Indian Claim 134 and Indian Claim 144, all in Section 4, Township 23 North, Range 19 East, Town of Oneida, Outagamie County, Wisconsin, more fully described as follows:

Commencing at the Northeast corner of Indian Claim 144; thence N53° 31'32"W, 41.26 feet along the northeasterly line of said Indian Claim to the westerly right-of-way of Seminary Road and the point of beginning; thence S35° 03'07"W, 529.48 feet along said right-of-way; thence to the S35 00'00"W, 1489.60 feet along said right-of-way to the northerly right-of-way of Old Seymour Road; thence N64° 16'22"W, 668.65 feet along said northerly right-of-way; thence N74° 32'33"W, 680.04 feet along said right-of-way; thence N81° 07'04"W, 378.48 feet along said right-of-way; thence N81° 07'04"W, 1021.85 feet along said right-of-way; thence N87° 00'54"W, 1021.85 feet along said right-of-way, to the west line of the Southwest 1/4-Northwest 1/4 of Section 4, T23N-R19E; thence N1° 03'01"E, 918.50 feet along said west line to the north line of said Southwest 1/4-Northwest 1/4; thence N89° 10'16"E 1323.00 feet along said north line to the northwest corner of Indian Claim 134; thence S89° 58'49"E, 1323.00 feet along said north lines of Indian Claim 134 and 144; thence N0° 32'05"E, 975.48 feet along a westerly line of Indian Claim 144 to the northern most corner of said Indian Claim; thence S53° 31'32"E, 1416.33 feet along the northeasterly line of said Indian Claim to the point of beginning.
