## RESOLUTION NO. 5-27-92-B

WHEREAS, The Oneida Tribal Council has delegated to the Oneida Business Committee authority to exercise the enumerated powers of the Oneida Constitution, Article IV as amended, and

WHEREAS, The Oneida Tribe has acquired in fee status the following parcel described as:

### PARCEL A:

Government Lot 3, in Section 5, Township 24 North, Range 19 East, Outagamie County, Wisconsin. AND Government Lot 1; the South half of the Northwest fractional quarter; the Southwest quarter of the Northeast quarter; and the Northeast quarter of the Southeast quarter of Section 6, Township 24 North, Range 19 East, Outagamie County, Wisconsin, EXCEPTING therefrom the following: (A) That part of Government Lot 1 described as follows: Commencing at the Southeast corner of said Section 6, thence North 30 East along the Easterly line of said Section 6, 38.20 feet to the North line of County Trunk VV, and there shall be the place of beginning; thence East along the Easterly line of said Section 6, 231.53 feet; thence South 89 45'W, 446.33 feet; thence South 0 15' East 200 feet to the North line of Highway VV; thence North 89 45' East along the North line of said highway 329.6 feet to the point of beginning. (B) That part of the South half of the fractional North half of said Section 6, described as follows: Commencing at the Northwest corner of the South half of the Northwest fractional quarter of said Section 6; thence South along the West line of said Section, 66 feet to the place of beginning; thence East parallel to the North line of the South half of the Northwest fractional quarter of said Section 6, 545 feet; thence South parallel to the West line of said section, 800 feet; thence West parallel to the North line South half of the Northwest fractional quarter of said Section 6, 545 feet to the West line of said Section: thence North along the West line of said Section, 800 feet to the place of beginning.

(C) That portion conveyed to Outagamie County by Deeds recorded in Volume 362 of Deeds, Page 485, and Jacket 10103 Image 10, Outagamie County Registry.

#### PARCEL B:

The North 1/2 of the North West fractional 1/4; The North West 1/4 of the North East 1/4 and the East 1/2 of the North East 1/4, of Section Six (6), Township Twenty-four (24) North, Range Nineteen (19) East, containing 153.58 acres, more or less, according to Government Survey, less excepting the Three (3) following described tracts of land, viz:-

- 1. That portion thereof heretofore conveyed by Deed recorded in Volume 665 of Records Page 537.
- 2. Commencing at the Northeast corner of said Section 6; thence South, along the East line of said Section, a distance of 33.12 feet, the place of beginning; thence continuing South, along the East line of said Section, 809.64 feet; thence South 85 degrees 6 minutes West, 270 feet; thence North 809.64 feet, to the South right-of-way line of County Trunk Highway "Y"; thence North 85 degrees 6 minutes East, along the South right-of-way line of said Highway, a distance of 270 feet, to the place of beginning.
- 3. Commencing at the Northeast corner of said Section 6; thence West, along the North line thereof, 270 feet, the place of beginning; thence South, along the West line of parcel described in Volume 785 of Records, Page 205, and parallel with the East line of said Section, 417 feet; thence West, parallel with the North line of said Section, 522 feet; thence North, parallel with the East line of said Section, 417 feet, to the North line thereof; thence East, along said North line, 522 feet, to the place of beginning.

- WHEREAS, The Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and
- NOW, THEREFORE, BE IT RESOLVED, that the Oneida Business

  Committee hereby requests the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcel in trust for the Oneida Tribe of Indians of Wisconsin.
