


- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and
- WHEREAS, the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Personnel Commission continues to clarify and enforce the Oneida Personnel Policies and Procedures Manual for the benefit of the Oneida Tribe and its employees, and
- WHEREAS, the Oneida Personnel Commission has received stipends which offset the cost and expenses related to membership as well as compensate for knowledge given in the course of duties and responsibilities, and
- WHEREAS, the Oneida Personnel Commission requires members to participate in interviewing, hearings and continuing education training in order to maintain and enhance skills utilized in their duties and responsibilities, and
- WHEREAS, the Oneida Personnel Commission has recently begun administering the entire grievance process thus causing increased time spent on these issues, and
- WHEREAS, the stipends paid to the Oneida Personnel Commission members have not been adjusted to reflect the current economy for many years, and
- WHEREAS, the Oneida Personnel Commission is forwarding the stipend rates set out below for approval by the Oneida Business Committee,

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby authorizes the following pay increases for compensation to the Oneida Personnel Commission members as follows:

\$50.00	Per half day Training, Pre-Screening, Interview Sessions (8:00 - 12:30
	or 12:30 - 5:00)
\$100.00	Per full day Training, Pre-Screening, Interview Sessions (8:00 - 5:00)
\$125.00	Per Grievance Hearing Session
\$100.00	Per Oneida Personnel Commission Regular and Special Meeting
\$75.00	Per Regular and Special Meeting for extra compensation to the
	Personnel Commission member for the administrative duties they
	perform in regards to each meeting, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the above stipend rates are to be effective June 1, 1997.
