#### **POSITION SUMMARY**

Provide Psychiatric services including psychiatric evaluations; prescribe psychiatric medications, treatment recommendations, and on-going medication management. This position will provide clinical supervision to our Psychiatric RN's. This position will work with children, adolescent and adult age groups and with a multitude of different Mental Health diagnosis ranging from the chronically mentally ill, to the client experiencing situational distress to individuals with substance abuse and/or co-occurring issues. Continuation of this position is contingent upon funding allocations.

## **DUTIES AND RESPONSIBILITIES:**

- Supervise, assign duties to, and coordinate the activities of staff to include evaluations, scheduling, disciplinary actions, hiring, training, orientation, coaching, and employee motivation.
- 2. Provide direct patient care to children, adolescents, and young adults, including individual psychiatric evaluations to include a complete written report of his findings from the evaluation within a timely manner to assure safe and efficient quality care.
- 3. Prescribe pharmaceuticals, other medications, and treatment regimens as appropriate to assessed Psychiatric conditions.
- 4. Function independently within the established protocols, under the professional medical supervision of a local psychiatrist licensed to practice in the State of Wisconsin.
- 5. Secure a health and developmental history from patient or parents; record findings and formulate critical evaluations.
- 6. Differentiate between normal and abnormal findings to recognize early stages of serious physical, emotional or mental problems.
- 7. Provide consultative services to the mental health, alcohol, tobacco and other drug abuse counselors in accordance with DHS 75 and DHS 35 of the Wisconsin Administrative Codes.
- 8. Provide direct psychological nursing care in the presence of illness or disability in order to maintain life, provide comfort, reduce stress and enhance coping abilities.
- Assist supervisor and designated team in assuring the quality and continuity of Behavioral Health Service to include referrals and contract care areas.
- 10. Assist supervisor in developing, updating protocols, policies and procedures as needed/requested.
- 11. Refer patients to other specialists and to relevant patient care components as appropriate.
- 12. Order test for lab and ancillary services to determine cause of patient condition. Develops treatment plan for condition.
- 13. May train and supervise medical students and residents engaged in specialty activities and procedures, as appropriate.

# **DUTIES AND RESPONSIBILITIES: (Cont.)**

- 14. Follow established departmental policies, procedures, and objectives, continuous quality improvement objectives, and safety, environmental, and/or infection control standards.
- 15. Participate in specified health promotion, education and/or prevention programs.
- 16. Provide treatment plans; write appropriate orders, including those for narcotics, stimulants, and depressant drugs.
- 17. Obtain patient histories and develop patient care charts, ensuring completeness and accuracy.
- 18. Provides health education to patients and families.
- 19. Provide direct psychological medical care in the presence of illness or disability in order to maintain life, provide comfort, reduce stress and enhance coping abilities.
- 20. Enhance professional growth and development through participation in educational programs, current literature, in-service meetings, and workshops.
- 21. May perform clinical research related to specific operations.
- 22. Contribute to a team effort and accomplishes related results as required.
- 23. Adhere to all Tribal Personnel Policies and Procedures, Tribal Standard Operating Procedures, and Area and Program Strategic Plans and Policies.
- 24. Maintain strict department security, confidentiality, and quality to meet professional standards of the department.
- 25. The above duties and responsibilities are not an all inclusive list but rather a general representation of the duties and responsibilities associated with this position. The duties and responsibilities will be subject to change based on organizational needs and/or deemed necessary by the supervisor.

#### PHYSICAL REQUIREMENTS/WORK ENVIRONMENT:
