Minutes of meeting held by Executive Committee

Was a quorum present – no

Name and title of council members present – Chairman Julius Danforth, Vice Chair Irene Moore, Treasurer Althea Schuyler, Secretary Eva Danforth

Minutes

Meeting called to order by Chairman Julius Danforth.

Secretary gave report of May meeting, motion made by Irene Moore to approve minutes as read. Seconded by Althea Schuyler. Carried.

Treasurers report read as follows:

Rehab Fund: \$421.20

Tribal Fund: \$596.78

Motion made by Eva Danforth to approve the treasurers report, seconded by Irene Moore. Carried.

Secretary read letters from Ashland Agency and council discussed the unapproved land application returned for Casper King. Council was informed that they had no right to reassign this land as it is trust land, and they agreed that it was an oversight on their part. Secretary was advised to write Mr. King and advise him of this.

The following 7 birth certificates were submitted for enrollment:

Debra Jean Kurowski, Arletta Jean Hawk, Sheila Diane Steele, Laura Lucas, Patricia Doxtator, Allen Lee House, Daniel David Kurowski

Motion was made by Irene Moore to approve the 7 certificates, seconded by Eva Danforth. Carried.

Motion made by Irene Moore to authorize Althea Schuyler, Treasurer to pay insurance premium of \$160.00 on CCC Bldg. for a 3 yr. period, seconded by Eva Danforth. Carried.

Council was informed that Frank Skenandore had purchased the house formerly owned by Joseph Skenandore from Whitney Skenandore.

An application for the 2 acres of land formerly assigned to Joseph Skenandore was presented for approval.

Motion was made by Irene Moore to approve the land application for Frank Skenandore, and also a release from Nellie Johnson of 2 acres of land and an application for same for William King. Motion seconded by Althea Schuyler. Carried.

Motion made by Irene Moore to give Nellie Johnson permission to use their lumber on chicken house to make an additional room on her house, seconded by Althea Schuyler. Carried.

Motion made by Eva Danforth to approve a loan for Sylvester Cornelius in amount of \$400.00 and also permission to tear down his old house to rebuild, seconded by Althea Schuyler. Carried.

Motion made by Irene Moore to authorize Secretary to write to Irvin Adams to inquire of him what he is going to do about his house as he has been living elsewhere for the past several months and he is to inform the Executive Board of his intent by the July meeting for they will assume he no longer wants it. Motion seconded by Althea Schuyler. Carried.

Council discussed the business of the annuity and the coming election, and agreed that Mrs. Moore should write to Mr. Riley and ask him if he could possibly meet with the committee and other interested persons before the General Council meeting. Council thought that a resolution should be drawn up to be presented at that meeting.

Motion by Althea Schuyler to adjourn, seconded by Irene Moore. Carried.
