## RESOLUTION 6-07-95-B

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, it is an Oneida National Priority to continue to preserve, protect, and improve the tribal land and environment, and
- WHEREAS, the Oneida Nation desires to promote the protection and preservation of its fish and wildlife resources through proper management for the use of its member and future generations; and
- WHEREAS, the Native American Fish and Wildlife Society (NAFWS) has been in existence since 1983 and has an established national office to assist the tribes in:
  - 1. Establishing new fish and wildlife programs:
  - 2. Supporting funding for tribal fish and wildlife programs;
  - 3. Educating and training Indian fish and wildlife biologists, managers, technicians and conservation officers.
  - 3. Representing future tribal fish and wildlife needs through Congressional process; and
  - 4. Promoting tribal management capabilities on a national level through an exchange of information via newsletters, technical bulletins, other pertinent information as well as regional training/workshops, and
- WHEREAS, the Oneida Nation fully supports the efforts and activities of the Native American Fish and Wildlife Society as stated above and in the Society's Article of Incorporation, and
- WHEREAS, in order to benefit from the above-listed services, a membership in NAFWS is required.

NOW THEREFORE BE IT RESOLVED: that the Oneida Nation become a member of the Native American Fish and Wildlife Society and to participate in the services provided by the organization and its staff.

BE IT FURTHER RESOLVED: that the Oneida Nation support the efforts of the NAFWS to secure funding to maintain the organization and the services that will be provided directly to tribal fish and wildlife programs.

BE IT FURTHER RESOLVED: that this resolution of support be submitted to the NAFWS within five (5) days of adoption of this resolution.

BE IT FINALLY RESOLVED: that the Oneida Chairperson, or delegate, is hereby authorized to submit a membership application, along with this resolution on behalf of the Oneida Tribe of Indians of Wisconsin with the contact office being the Chairperson's Office.
