BC Resolution 06-10-15-D Regarding Pardon of Kelly Braaten

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee is delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Pardon and Forgiveness Screening Committee reviewed the pardon application of Kelly Braaten at a duly called hearing held on May 21, 2015; and
- WHEREAS,** the requirements of the Pardon and Forgiveness Law have been fulfilled.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee by this resolution hereby:

- ☒ Approves the pardon of Kelly Braaten for the crime(s) of D.U.I 5th, D.U.I. 6th and Bail Jumping, and notifies the Oneida Tribe of Indians of Wisconsin and its agencies that she is recognized as a member of the Oneida Tribe of Indians of Wisconsin to have all the benefits and opportunities available to all other persons as if the criminal offenses(s) pardoned by this resolution did not exist. The pardon has been approved based on the following:
1. Paid all fines
 2. Continues AA meetings
 3. Sober since 2009
