BC Resolution 06-10-15-E Regarding Pardon of Richard Guyette

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee is delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Pardon and Forgiveness Screening Committee reviewed the pardon application of Richard Guyette at a duly called hearing held on May 21, 2015; and
- WHEREAS,** the requirements of the Pardon and Forgiveness Law have been fulfilled.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee by this resolution hereby:

 2. Current involvement in alcohol abuse
 3. Admitted unlawful behavior
 4. Needs Behavioral Health
