

RESOLUTION 06-10-98-D

AMENDMENT TO RESOLUTION #5/22/96A

WHEREAS, The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS the Oneida General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the General Tribal Council and is at all times subject to the review powers of the Oneidas General Tribal Council, and,

WHEREAS, the Oneida Business Committee has adopted an Indian Preference Policies in resolutions # 2/1/91B, 5/19/93B and in 2/15/95A, and in the HRD hiring policy, and,

WHEREAS, the Indian preference policy attachment to construction contracts was adopted by the Oneida Business Committee Resolution #BC 4/3/96A with Amendments by resolution # 5/22/96A, and,

WHEREAS, there is recommended an amendment to this attachment to allow the Oneida Tribe to grant and maintain greater Indian Preference in all construction projects within their reservation boundaries, not limited to Capital Improvements Projects only, and,

NOW, THEREFORE, BE IT RESOLVED, that the attachment, Indian Preference Policy, Rider I, is hereby adopted to be implemented and attached to all Oneida construction contracts that are entered into between the Tribe and a vendor for work to be performed within the exterior boundaries of the Oneida reservation, and

NOW THEREFORE BE IT RESOLVED, that to the extent that this attachment conflicts with any attachments adopted by resolutions BC-4-30-85A or BC-5-19-93-C, this attachment shall govern and those conflicting portions of those resolutions are hereby superseded, and

NOW THEREFORE BE IT RESOLVED. That this resolution and attachment shall be forwarded for implementation to the Compliance Division Director.
