- WHEREAS, the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe of Indians is committed to the well-being of all Oneida Tribal members and their families, and
- WHEREAS, the American Indian Center of the Fox Valley, a program of Goodwill Industries NCW is committed to the welfare of Oneida tribal members and other Native Americans living both on and off the reservation, and
- WHEREAS, the Oneida Tribe and American Indian Center of the Fox Valley have supported, collaborated and established meaningful relations working for the welfare of the Oneida members and their families as well as other Native Americans living both on and off the reservation, and
- **WHEREAS,** the Oneida Tribe of Indians of WI supports the American Indian Center of the Fox Valley's work with the health and education programs of the surrounding tribes, and
- WHEREAS, the Oneida Tribe of Indians of WI establishes their commitment to continue to support the work, efforts, and mission of the American Indian Center of the Fox Valley, and

NOW THEREFORE, BE IT RESOLVED, the Oneida Business Committee affirms our support to the American Indian Center of the Fox Valley.
