


Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to ald them.



Resolution 06-24-09-F





WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section I of the Oneida Constitution by the Oneida General Tribal Council; and

WHEREAS, Austin Straubel International Airport, a municipal corporation and Lessor, and Oneida Seven Generations Corporation, an Oneida Tribally-chartered corporation and Lessee, are parties to a Ground Lease, effective date of June 1, 2004; and

WHEREAS, the Ground Lease provides for tribal roadway access and underground fiberoptic cable installation between South Point Road, Green Bay, and the Oneida Casino, Green Bay, and the parties have entered into a First Ground Lease Extension Agreement, effective January 1, 2009; and

WHEREAS, the First Ground Lease Extension Agreement provides that the Oneida Seven Generations Corporation, as Lessor, agrees to pay all base rents and base rent adjustments as provided in the Agreement; and



UGWA DEMOLUM YATEHE Because of the help of this Oneida Chief in cementing a friendship between the six nations and the colony of Pennsylvania, a new nation, the United States was made possible.

- WHEREAS, Oneida Seven Generations Corporation, as Lessee, has agreed to obtain a Guarantee from the Oneida Tribe of Indians of Wisconsin, as Guarantor, as a condition of the First Ground Lease Extension Agreement; and
- WHEREAS, the Oneida Tribe as Guarantor guarantees and covenants that it shall assume all rights, responsibilities and obligations of the First Ground Lease Extension Agreement in the event the Oneida Seven Generations Corporation is dissolved or becomes in default of any of its obligations under the First Ground Lease Extension Agreement; and
- WHEREAS, the Oneida Tribe as Guarantor further guarantees and covenants that it shall not use its status as a sovereign nation or its sovereign immunity as a defense for the enforcement of the provisions of the First Ground Lease Extension Agreement or the enforcement of the Guarantee; and
- WHEREAS, the Oneida Tribe as Guarantor further agrees that it consents to be sued for the purpose of enforcing the Guarantee and all duties and obligations thereunder in the Wisconsin State Court System.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby approves and authorizes a limited waiver of sovereign immunity for the Guarantee to the First Ground Lease Extension Agreement between the Austin Straubel International Airport and Oneida Seven Generations Corporation, for the purpose of enforcing all the duties and obligations as set forth in the First Ground Lease Extension Agreement.

CERTIFICATION
