


# Oneida Tribe of Indians of Wisconsin

## BC Resolution 06-27-12-B Dedication of Carry-Over Funds from Prior Year Head Start Before /After Program

- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS,** the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS,** the General Tribal Council adopted resolution # GTC-1-20-93-A directing the Oneida Tribe to develop plans to provide early childhood education to all Tribally enrolled or eligible to be enrolled 3 and 4 year olds within the Tribe's service area, and
- WHEREAS,** the mission statement of the Oneida Tribe Early Head Start and Head Start Program is to promote healthy prenatal outcomes, enhance the development of young children, foster well-being of families while respecting cultural values, and
- WHEREAS,** the Head Start Before/After Program serves the childcare need for low income parents during specific approved activities, and
- WHEREAS,** the funding source for the Head Start Before/After Program is provided by external funding [local and state childcare subsidies], and
- WHEREAS,** the Head Start Before/After Program is a self-funded program which requires no Tribal contribution and as such is impacted solely as a result of the ability to accurately manage the costs related to the program and the external funding, and
- WHEREAS,** the Oneida Business Committee has determined that unspent funds from the prior fiscal year derived from the Head Start Before/After Program should be allocated to the Head Start Before/After Program to fund expansion, enhancement, or maintenance of the program as set forth in the next fiscal year budget.

**NOW THEREFORE BE IT RESOLVED** that the Oneida Business Committee directs that with each fiscal year budget the Finance Department shall estimate the unexpended external funds within the Head Start Before/After Program for the purposes of expansion, enhancement, or maintenance of the program. For purposes of budgeting, this estimate shall be verified by the annual audit and under no circumstances shall such carry-over funds be supplemented by Tribal contributions in the event the estimate exceeds actual funds.

**IT IS FURTHER RESOLVED THAT** the Head Start Before/After Program shall identify in separate documentation how carry-over funds will be allocated and such separate documentation shall be incorporated into the budget document and is subject to final approval of General Tribal Council.
