## Zoning and Shoreland Protection Law Amendments: Nuisance Provisions

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and

**WHEREAS**, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV of the Oneida Tribal Constitution by the Oneida General Tribal Council; and

WHEREAS, the Zoning and Shoreland Protection law (Law) was adopted by the Oneida Business Committee in 1990; and

whereas, the Law defines "public nuisances" and contains specific circumstances that may qualify as public nuisances, including glare; storage of chemicals; outdoor storage and waste disposal; noise; emission smoke; emission of particulate matter, heat and glare; toxic and noxious matter; radioactivity or electrical disturbance; vibration; and storage of vehicles; and

whereas, the Law does not address additional situations that can amount to a public nuisance such as noxious weeds and other rank growth of vegetation; the exterior storage of scrap lumber, junk, trash and other debris; multi-textured or multi-colored exterior patchwork, repairs or reconstructions; or storage of vehicles other than a car or truck in front, back and side yards; and

WHEREAS, amendments to the Law would add these additional provisions and require the Zoning Administrator to consider the surrounding conditions, definition of "public nuisance," and the intent of the public nuisance section to determine whether a public nuisance exists; and

**WHEREAS,** a public hearing on the amendments was held on June 23, 2011, in accordance with the Administrative Procedures Act.

**NOW THEREFORE BE IT RESOLVED**, that the attached amendments to the Zoning and Shoreland Protection Law (Law) are hereby adopted.
