## RESOLUTION # 8-01-01-E

### Fee to Trust Resolution for Babcock I & II Property

**WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and

**WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and

**WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

**WHEREAS,** the Oneida Tribe has acquired in fee status the following parcel described as:  
Babcock I & II Property

**WHEREAS,** the parcels are described as follows:

Lot One (1) of Certified Survey Map recorded in the office of the Register of Deeds for Brown County, Wisconsin in Volume 7 Certified Survey Maps page 59 said map being a part of Private Claim Twenty-two (22) West, in the Village of Ashwaubenon, Brown County, Wisconsin. AND Lot One (1) of Certified Survey Map recorded in the office of the Register of Deeds for Brown County, Wisconsin in Volume 6 Certified Survey Maps page 465, said map being a part of Private Claim Twenty-two (22) West, in the Village of Ashwaubenon, Brown County, Wisconsin.

AND

Lot One (1) of Certified Survey Map recorded in the office of the Register of Deeds for Brown County, Wisconsin in Volume 22 Certified Survey Maps page 214, said map being all of Lot One (1) of Volume 3 Certified Survey Map 427, being part of Private Claim Twenty-two (22) West, in the Village of Ashwaubenon, Brown County, Wisconsin.

Tax Parcel No. VA-149, VA-147-3 and VA-147-4

That part of Private Claim Twenty-two (22) West side of Fox River, in the Village of Ashwaubenon, Brown County, Wisconsin, described as follows:

Commencing at the northwest corner of Private Claim 23, W.S.F.R. as

remonumented by the Brown County Surveyor; thence South 63°56'40" East 54.25 feet along the north line of Private Claim 23 to the point of beginning on the east line of Packerland Drive (C.T.H. "EB"); thence North 30°34'07" East 212.15 feet; thence North 60°09'41" East 487.33 feet to the south line of Airport Road (C.T.H. "GG"); thence along said south line South 58°59'19" East 106.07 feet; thence continuing along said south line along the arc of a curve to the left with a radius of 11,559.16 feet and the chord of which bears South 60°08'42" East 466.59 feet to the west line of Clive Street; thence along said west line South 26°24'40" West 13.92 feet; thence continuing along said west line along the arc of a curve to the left with a radius of 55 feet and the chord of which bears South 30°56'45" West 79.05 feet; thence continuing along said west line along the arc of a curve to the right with a radius of 25 feet and the chord of which bears South 5° 42' 23" West 17.68 feet; thence continuing along said west line South 26° 24' 40" West 428.19 feet to the north line of Private Claim 23; thence along said north line North 63° 56' 40" West 857.64 feet to the point of beginning and containing 10.257 acres of land.


Tax Parcel No. VA-147
