RESOLUTION NO. 8-5-92-C

WHEREAS, The Oneida Tribal Council has delegated to the Oneida Business Committee authority to exercise the enumerated powers of the Oneida Constitution, Article IV as amended, and

WHEREAS, The Oneida Tribe has acquired in fee status the following parcel described as: VANDEWALLE PROPERTY.

<u>PARCEL I</u> The East 10 rods of that part of Lot Thirteen (13) lying South of the highway in Section Five (5), Township Twenty-three (23) North, Range Nineteen (19) East, Outagamie County, Wisconsin.

PARCEL II Claims 117, and 128, Claim 129, less that part of said Claim described in Volume 890 of Records, Page 177; Claim 118, less the following two (2) described properties as recorded in Volume 191 of Deeds, Page 143 and in Volume 978 of Records, Page 648; Commencing at point in center of highway, between claims 118 and 119, intersected by South boundary of Section Four (4), Township Twenty-one (21) North, Range Nineteen (19) East, and running thence in Northeasterly direction along center line of said highway, 20 rods, thence running in a Northwesterly direction parallel With Southwesterly boundary of said claim 118, 16 rods thence in Southwesterly direction parallel with center line said highway 20 rods, to Southwest boundary of claim 118; thence along Southwesterly boundary said claim 118, 16 rods to place of beginning and excepting, Commencing at the intersection of the centerlines of Old Seymour Road and Second Ridge Road; thence South 35° 00' West, along the centerline of Second Ridge Road, 1543.00 feet; thence South 35° 13' West along the centerline of Second Ridge Road, 1250.60 feet to the point of beginning; thence continuing South 35° 13' West, along said centerline 208.72 feet to the Northeasterly line of the South 20 rods of said Private Claim #118; thence North 58° 11' West, along said Northeasterly line, 208.72 feet; thence North 35° 13' East, 208.72 feet; thence South 58° 11' East 208.72 feet to the point of beginning.

All that part of Claim 130 lying West of West Ridge Road, excepting that part of said claim 130 described in Volume 890 of Records, Page 177.

All that part of claim 133 described in Volume 234 of Mortgages, Page 31 as follows: Beginning at the Northeast corner of Northwest 1/4 of Southwest 1/4 of Section Four (4), Township Twenty-three (23) North, Range Nineteen (19) East; thence East on the quarter line 7 chains; thence South 65° East 13.46 chains; thence South 35° West 3.72 chains; thence North 65° West, 18 chains; and thence North 2.34 chains to the place of beginning, excepting therefrom 1 acre sold to Edgar Moore (a/k/a Edgar More) per deed dated March 30, 1916 recorded in said County in Volume 158 of Deeds, Page 36, and therein described as follows: Commencing at a point in Claim 133 in the West boundary line of the West Ridge Road which point is the most Southerly corner of land now owned by Martin McCormick, according to the records of Outagamie County this date and running thence Southwesterly along the West boundary line of said West Ridge Road 8 rods; thence running Northwesterly at right angles to the West boundary line of said West Ridge Road 20 rods; thence Northeasterly and parallel with the West boundary line of said West Ridge Road 8 rods; and thence Southeasterly at right angles to the West boundary line of said West Ridge Road 20 rods to the place of beginning and excepting that part sold to Moses E. King and wife Minnie C. as in Volume 171 of Deeds, Page 83 described as follows: Commencing at a point 5.24 chains South 35° West of the Southeast corner of Claim 134 and run thence North 64.5° West, 5 chains; thence South 35° West, 1 chain; thence South 64.5° East, 5 chains; thence North 35° East, 1 chain to the place of beginning. The Northwest 1/4 of the Southwest 1/4, excepting therefrom that part of said Northwest, Southwest described in Volume 890 of Records Page 177 and all that part of the Southwest 1/4 of the Northwest 1/4 described as follows: Commencing at Southeast corner of Southwest 1/4 of Northwest 1/4, Section Four (4), Township Twenty-three (23) North, Range Nineteen (19) East, running thence West on the quarter line, 19.50 chains to the quarter stake; thence North 5 chains to the middle of Seymour Road; thence South 88° East on Seymour Road a distance of 15 chains or 60 rods; thence South 81 East on Seymour Road a distance of 5.08 chains; thence South 4 chains to place of beginning, excepting therefrom the premises described in Volume 149 of Deeds, Page 460 as follows: Commencing at the 1/16th stake on the East and West quarter line being the Southeast corner of Southwest 1/4 of Northwest 1/4 Section Four (4), Township Twenty-three (23) North, Range Nineteen (19) East, running thence North 4 chains to the middle of Seymour Road; thence North 81° West 4.75 chains; thence South 4.70 chains to the East and West quarter line; thence East 4.70 chains to the place of beginning. All of the above being in Section Four (4), Township Twenty-three (23) North, Range Nineteen (19) East, Outagamie County, Wisconsin.

The Southeast 1/4 of the Southeast 1/4 and the East 10 rods of the Northeast 1/4 of the Southeast 1/4 and the East 10 rods of Lot 14 all in Section Five (5), Township Twenty-three (23) North, Range Nineteen (19) East, Outagamie County, Wisconsin.
