- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined that the overall goal of the Oneida Tribe is to protect, maintain and improve the standard of living and the environment in which the Oneida people live, and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin established the Oneida Elderly Services Department to whose mission is to "Assist our Elders to maintain an independent, healthy, productive and quality lifestyle through love, caring and respect by the services we provide.", and
- WHEREAS, the Oneida Tribe of Indians of Wisconsin and the Oneida Elderly Services Department fully supports the Community Food Projects, Traditional Gardening in Indian Communities programs proposed by the National Society of American Indian Elderly (NSAIE). The Elderly Services Department operates a Title VI Elder Nutrition Site and will benefit from the development of these projects, and
