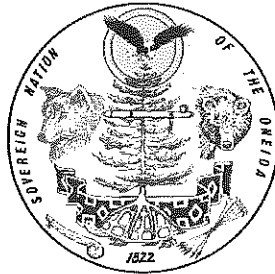


Oneida Tribe of Indians of Wisconsin

BC RESOLUTION 08-14-13-C

Fee to Trust for tax parcel numbers: HB-1480, HB-1695-10, HB-1493-A-42, HB-1695-19, HB-1493-A-23, HB-543-3, HB-1695-20, HB-1415-1

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty Tribe organized under the laws of the United States of America, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida General Tribal Council has delegated the authorities of Article IV of the Oneida Tribal Constitution to the Oneida Business Committee, and
- WHEREAS,** the Oneida Tribe has acquired in fee status properties referenced with the following tax parcel numbers: **HB-1480, HB-1695-10, HB-1493-A-42, HB-1695-19, HB-1493-A-23, HB-543-3, HB-1695-20, HB-1415-1** and
- WHEREAS,** the Oneida Business Committee, through resolutions **#4-12-06-H, #4-12-06-I, #4-12-06-W, #10-24-07-C, #4-12-06-X, #4-12-06-BB, #4-12-06-DD, and #4-12-06-V,** requested the United States Bureau of Indian Affairs (BIA) initiate and carry out the required process to place the above described properties in trust for the Oneida Tribe, and
- WHEREAS,** the Oneida Business Committee, based upon the recommendations from the Division of Land Management, has determined that significant changes need to be made to the Tribe's application to have these properties taken into trust status, and
- WHEREAS,** the Oneida Business Committee has determined that it is in the Tribe's best interest to rescind its requests to have the BIA process the Tribe's request to have these properties placed into trust status in order to provide the Division of Land Management sufficient opportunity to make the changes prior to re-submitting a new request to the BIA to have these properties placed into trust status.

NOW THEREFORE BE IT RESOLVED, that the Business Committee rescinds resolutions **#4-12-06-H, #4-12-06-I, #4-12-06-W, #10-24-07-C, #4-12-06-X, #4-12-06-BB, #4-12-06-DD, and #4-12-06-V.**
