\$25 million that we are going to face next year.

Ed Delgado said upon the identification of \$3.9 million of a positive variance, we should have considered our employees a little more.

Trish King said my support of this motion is because we did consider the employees, some of the benefit programs for the employees. We did not

disregard them.
