RESOLUTION # 8-28-96-D

WHEREAS the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS the Oneida Tribe has acquired in fee status the following parcel described as: Wintergreen Investments I, Tax Parcel Nos. #HB-1273, 1277, 1286, 1295-1, 1293, 240, 242, 245, 248, 251, 253, 253-1, 255, 256, 17-0-2177-00, 17-0-2165-00, 17-0-2172-00, 17-0-2174-00

WHEREAS, the parcel is described as follows:

PARCEL I:

PART OF INDIAN CLAIMS 115, 120 AND 125; BEING PART OF SECTION 4 & 9, TOWN OF ONEIDA, OUTAGAMIE COUNTY, AND PART OF SECTIONS 3 & 10, TOWN OF HOBART, BROWN COUNTY, ALL BEING IN TOWNSHIP 23 NORTH, RANGE 19 EAST OF THE FOURTH PRINCIPAL MERIDIAN, STATE OF WISCONSIN, MORE FULLY DESCRIBED AS FOLLOWS:



NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
