Resolution # <u>8-29-07-A</u>

Adopting Amendments to the Corporate Charter of the Oneida Airport Hotel Corporation

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Business Committee adopted resolution #BC-2-24-84-B which adopted the corporate charter for the Oneida Airport Hotel Corporation; and
- WHEREAS, the Oneida Business Committee adopted #BC-5-15-91-N which amended the corporate charter; and
- WHEREAS, the Oneida Business Committee adopted resolution #BC-3-1-95-C which further amended the corporate charter by designating that the distribution of profits from the corporation should be utilized to pay down debts of the corporation; and
- WHEREAS, the Oneida Business Committee adopted resolution #BC-4-16-97-E which further amended the corporate charter which repealed the profit allocation set forth in the 1995 resolution; and
- WHEREAS, the Oneida Business Committee adopted resolution #BC-8-23-00-E which further amended the corporate charter to expand the purposes and powers of the corporation; and
- WHEREAS, the Oneida Business Committee adopted resolution # BC-8-29-01-A which

further amended the corporate charter to correct certain typographical errors; and

- WHEREAS, the Oneida Business Committee adopted resolution #BC-7-30-03-A which further amended the corporate charter regarding the distribution of profit from the corporation; and
- WHEREAS, the Oneida Business Committee adopted resolution # BC-5-15-04-B which further amended the corporate charter to further expand the purposes and powers of the corporation; and
- WHEREAS, the Oneida Business Committee is presented this resolution which would amend the corporate charter to further expand the purposes of the corporation; and

NOW THEREFORE BE IT RESOLVED THAT, the Oneida Business Committee amends the Oneida Airport Hotel Corporations charter; amending the board of director's terms of office from four (4) years to five (5) years effective with each new appointment.
