RESOLUTION # 8-30-9/- B

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Resolution #4-20-90 adopted an Oneida Tribal Sanitary District Ordinance and an Oneida Utilities Commission, and

WHEREAS, Resolution # 8-10-90-F authorized the Oneida Utilities Commission to manage and be financially accountable for both a water and sewer system, and

WHEREAS, an amended Oneida Tribal Sanitary District Ordinance is required in order to provide appropriate financial and operational guidelines to administer a sewer and water system, and

WHEREAS, said amended ordinance shall include rates and charges that are sufficient to pay all costs of operation and maintenance of the system and to produce net revenues equal to the maximum amount of principal and interest on all obligations payable from revenues of the system in any subsequent fiscal year, and

WHEREAS, the amendments to the Oneida Tribal Sanitary District Ordinance fulfills all the federal and tribal requirements for a rate ordinance, and existing well regulations.

NOW THEREFORE BE IT RESOLVED that the Oneida Business Committee does hereby enact the attached amendments in order to address required changes in the Oneida Tribal Sanitary

AMENDMENT II

- XVIII. C. Individual residential well owners can apply to leave their wells uncapped for one or more of the following reasons:
 - 1. That the well be used for outside activities only, i.e. watering of gardens, lawns and livestock.
 - 2. That all residential units be connected to the tribal water system and that all sewers be connected only to the tribal system.
 - 3. That each well left uncapped is tested to make sure that it meets all code requirements both for plumbing and health issues prior to that connection of tribal water and that it be tested each following year. Cost of testing will be born by the property owner, and performed by the utility department.
 - 4. If any well is not used for a period of one (1) year after the municipal connection, it shall be capped and the cost of the capping borne by the property owner.
