RESOLUTION # 8.30-91-C

- the Oneida Tribe of Indians of Wisconsin is a federally WHEREAS, recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- the Oneida Business Committee has been delegated the WHEREAS, authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has authorized the Oneida Utilities Commission to be the entity to operate and construct a water and sanitary sewer facility of the Oneida Tribal Sanitary District by Ordinance No. 4-20-90, as amended by Resolution # 5-15-90-Q, as amended by Resolution #8-30-91-B, and
- WHEREAS, the Farmers Home Administration (FMHA) agrees to make two loans to the Oneida Utilities Commission, in the amount of \$76,000 and \$455,000 respectively, which loans are evidenced by separate Water and Sewage System Revenue Bonds, Series 1991, (the Bonds issued by the Commission and delivered to the FMHA), and
- WHEREAS, as a condition of making the loan, the FMHA has required that the Oneida Tribe guaranty the payment of the bonds, and
- the issuance of the Bonds by the Commission, and the WHEREAS, acceptance thereof by the FMHA, will give rise to substantial benefits to the Tribe including the enhancement of the health and welfare of economics of the Oneida Tribal Government, its members, as well as the public, by providing a water and sanitary sewer service within the Oneida Tribal Sanitary District.

## GUARANTY

THIS GUARANTY, dated as of \_\_\_\_\_\_, 1991, executed by the ONEIDA TRIBE OF INDIANS OF WISCONSIN, a federally recognized Indian tribe organized under Section 16 of the Indian Reorganization Act of 1934, 25 U.S.C. § 476 (the Tribe), in favor of the UNITED STATES OF AMERICA, FARMERS HOME ADMINISTRATION (the FmHA);

#### WITNESSETH:

WHEREAS, the Tribe has established the Oneida Utilities Commission (the Commission) as an instrumentality of the Tribe for the purpose of constructing and operating the water and sanitary sewer facilities of the Oneida Sanitary District within the boundaries of the Tribe's Reservation; and

WHEREAS, the FmHA has made a loan to the Commission in the principal amount of \$76,000 (the Loan), which Loan is evidenced by a \$76,000 Water and Sewage System Revenue Bond, Series A (the Bond) issued by the Commission and delivered to the FmHA; and

WHEREAS, as a condition of making the Loan, the FmHA has required that the Tribe execute and deliver this Guaranty; and

WHEREAS, the Loan made by the FmHA to the Commission, the issuance of the Bond by the Commission and the acceptance thereof by the FmHA will give rise to substantial economic and other benefits to the Tribe, will further the governmental interests of the Tribe in providing water service within the Oneida Sanitary District, and will further the health and welfare of the residents of the Reservation, and the Tribe desires to facilitate the making of the Loan and to guarantee the payment of principal of and interest on the Loan and the Bond as set forth more fully herein;

NOW THEREFORE, in consideration of the making of the Loan and acceptance of the Bond by the FmHA, the Tribe hereby agrees as follows:

Section 1. <u>Guaranty</u>. The Tribe hereby unconditionally guarantees to the FmHA the full and prompt payment of the principal of and interest on the Loan and the Bond when and as the same shall become due. All payments by the Tribe shall be paid in lawful money of the United States of America to the FmHA. Each and every default in the payment of the principal of or interest on the Loan and the Bond shall give rise to a separate cause of action hereunder and separate suits may be brought hereunder as each cause of action arises.

Section 2. <u>Rights of FmHA</u>. The Tribe covenants that if default is made in the payment of any installment of principal of or interest on the Loan or the Bond when such principal or interest becomes due, the Tribe will, upon demand, pay to the FmHA the amount then due and payable on the Loan and the Bond for principal and interest, with interest upon the overdue principal and, to the extent that payment of such interest shall be legally enforceable, upon overdue installments of interest at the rate borne by the Loan and the Bond.

IN WITNESS WHEREOF, the Tribe has caused this Guaranty to be executed by its duly authorized officers and to be delivered as of the date first above written.

#### GUARANTY

THIS GUARANTY, dated as of <u><u>Grig</u> <u>30</u></u>, 1991, executed by the ONEIDA TRIBE OF INDIANS OF WISCONSIN, a federally recognized Indian tribe organized under Section 16 of the Indian Reorganization Act of 1934, 25 U.S.C. § 476 (the Tribe), in favor of the UNITED STATES OF AMERICA, FARMERS HOME ADMINISTRATION (the FmHA);

## WITNESSETH:

WHEREAS, the Tribe has established the Oneida Utilities Commission (the Commission) as an instrumentality of the Tribe for the purpose of constructing and operating the water and sanitary sewer facilities of the Oneida Sanitary District within the boundaries of the Tribe's Reservation; and

WHEREAS, the FmHA has made a loan to the Commission in the principal amount of \$455,000 (the Loan), which Loan is evidenced by a \$455,000 Water and Sewage System Revenue Bond, Series B (the Bond) issued by the Commission and delivered to the FmHA; and

WHEREAS, as a condition of making the Loan, the FmHA has required that the Tribe execute and deliver this Guaranty; and

WHEREAS, the Loan made by the FmHA to the Commission, the issuance of the Bond by the Commission and the acceptance thereof by the FmHA will give rise to substantial economic and other benefits to the Tribe, will further the governmental interests of the Tribe in providing sanitary sewer service within the Oneida Sanitary District, and will further the health and welfare of the residents of the Reservation, and the Tribe desires to facilitate the making of the Loan and to FULLINES the pryment of principal of and interest on the Loan and the Bond as set forth more fully herein;

NOW THEREFORE, in consideration of the making of the Loan and the acceptance of the Bond by the FmHA, the Tribe hereby agrees as follows:

Section 1. <u>Guaranty</u>. The Tribe hereby unconditionally guarantees to the Frid-IA the full and prompt payment of the principal of and interest on the Loan and the Bond when and as the same shall become due. All payments by the Tribe shall be paid in lewful money of the Urdted States of America to the Frid-IA. Each and every default in the payment of the principal of or interest on the Loan and the Lond shall give rise to a separate cause of action hereunder and separate suits may be brought hereunder as each cause of action arises.

Section 2. Rights of FmHA. The Tribe covenants that if default is made in the payment of any installment of principal of or interest on the Loan or the Bond when such principal or interest becomes due, the Tribe will, upon demand, pay to the FmHA the amount then due and payable on the Loan and the Bond for principal and interest, with interest upon the overdue principal and, to the extent that payment of such interest shall be legally enforceable, upon overdue installments of interest at the rate borne by the Loan and the Bond.
