- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has determined as part of its Seven Generation Commitment "to build a solid educational foundation by addressing human needs of all its members throughout the circle of life", and
- WHEREAS, the Oneida Tribe has established the Oneida Nation Arts Program to provide the highest quality educational and support services to all children and families and to empower the children through the use of developmental practices which reflect the unique cultural heritage of the Oneida people, and
- WHEREAS, the Oneida Nation Arts Program with the collaboration of the Wisconsin Arts Board, Heartland fund, National Endowment of the Arts and various state, local and federal funding sources would like to preserve, protect and share the cultural heritage of the Oneida people for the next seven generations, and

NOW, THEREFORE, BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin in collaboration various funding sources authorizes and submits this grant application for the Performing Arts Series to bring performing artists to the Oneida Concert Series, Community Development Projects for cultural tourism events, the Regranting Program to support local Oneida Artists and to pursue other funding opportunities to continue the long-term efforts of the Oneida Nation Arts Program.
