RESOLUTION # 9-21-94 BB

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Carmen Danforth has made application for a long-term lease for residential purposes more particularly described as follows:

A parcel of land located within Claim 147, Section 3, T 23 N., R 19 E., more particularly described as: Commencing at the SE corner of said Claim 147 where it intersects with CTH "E"; thence N 60°W., a distance of 621.70 feet; thence N 29°E., a distance of 91.30 feet to the Point of Beginning; thence N 60°05'W., a distance of 130 feet; thence N 29°55'E., a distance of 90 feet; thence S 60°05'E., a distance of 130 feet; thence S 29°55'W., a distance of 90 feet, more or less, to the point of beginning, containing .27 acres, more or less, subject to all valid existing rights-of-way of record.

NOW, THEREFORE BE IT RESOLVED, by this Committee in _____ session assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat. 539), as amended, 25 USC 415, for the above described land with a 25-year term which shall automatically and without notice renew for an additional term of 25 years at a total rental of \$1.00 annually, or \$50.00 for fifty years; and

BE IT FURTHER RESOLVED, that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe of Indians of Wisconsin.
