

## RESOLUTION # 9-21-94 M

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Edward and Agnes Wojkiewicz Property, 2803 W. Mason St., Green Bay, Wisconsin.

WHEREAS, the parcel is described as follows: Parcel D is described as:

That part of Lots Ten(10) and Twenty-two (22), Section Thirty (30), Township Twenty-four (24) North, Range Twenty (20) East, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin, described as follows:

Commencing at the East Quarter-section corner of said Section; thence South 0° 16' 14" West along the East line of said Section 528.00 feet to the point of beginning; thence continuing South 0° 16' 14" West along said East line 1059.21 feet; thence South 89° 49' 26" West along the North line of Outlot 1, Volume 8 Certified Survey Maps, page 115, Brown County Records, 324.32 feet; thence North 0° 02' 04" East 331.16 feet to the Southeast corner of Parcel A, Volume 3 Certified Survey Maps, page 343, Brown County Records; thence North 0° 05'36" East 729.57 feet to the Southeast corner of Lot 2, Volume 8 Certified Survey Maps, page 19, Brown County Records; thence North 0° 16' 14" East along the East line of said Lot 2, 280.50 feet; thence South 89° 54' 17" East 123.75 feet; thence South 0° 16' 14" West 280.50 feet; thence South 89° 54' 17" East 204.17 feet to the point of beginning.
