

RESOLUTION # 9-21-940

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Edward and Agnes Wojkiewicz Property, 2803 W. Mason St., Green Bay, Wisconsin.
- WHEREAS, the parcel is described as follows: Parcel B is described as:

That part of Lot Ten (10), Section Thirty (30), Township Twentyfour (24) North, Range Twenty (20) East, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin, Described as follows:

Commencing 7 1/2 rods West of the Quarter post between Sections 29 and 30, Township 24 North, Range 20 East, the point of beginning; thence West a distance of 5 rods; thence South 32 rods; then East 5 rods, thence North 32 rods to the place of beginning, excepting therefrom that part described in Jacket 9612 Records Image 36, as Document Number 1065190.

Subject to easement described in Jacket 11126 Records Image 32, as Document Number 1101973.

- WHEREAS, the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will bre paid up to trust placement, and

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
