## BC Resolution 09-24-14-0 Appointing Representative on the Wisconsin Department of Corrections Religious Practices Advisory Committee

**WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and

**WHEREAS,** the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and

**WHEREAS,** the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and

whereas, the State of Wisconsin, Department of Corrections' Religious Practices Advisory Committee was established in 2002 and is successor to a steering committee which examined inmate religious practices since the Department of Corrections became an independent state agency under the 1989 Wisconsin Act 31: and

WHEREAS, the purpose of the State of Wisconsin, Department of Corrections' Religious Practices Advisory Committee is to review inmate religious issues that arise within the department; consult with staff, volunteers, community religious groups and the Wisconsin Department of Justice on these issues; apply, review and revise internal religious policies and procedures; and resolve any religious issues in a way that promotes consistency and fairness among the various religious faith; and

**WHEREAS,** in 2010 Chairman Richard G. Hill recommended appointment of Council Member Melinda J. Danforth to be appointed to this committee; and

WHEREAS, this appointment is ongoing and the Oneida Business Committee desires to re-confirm Vice Chairwoman Melinda J. Danforth's ongoing representation of the Tribe and all Tribes on the Religious Practices Advisory Committee;

**NOW THEREFORE BE IT RESOLVED,** that the Oneida Business Committee appoints Vice Chairwoman Melinda J. Danforth to represent the Oneida Tribe and other Tribes on the State of Wisconsin, Department of Corrections' Religious Practices Advisory Committee.
