Tina Danforth stated I do support the project. I do support the cause. I do support the fact that we have people going back and forth between the communities. What I'm not okay with: one, is that a procedural exception is in front of us because that tells me that there wasn't enough planning--this is more of a management issue; two, is that it's three days before the event. Today is the

25^{th.} These people are scheduled to leave on the 28th. Why are we having this one as an add-on, two, three days before the event? I'm not okay with that. I support what is happening. I understand what's happening. I sat with elders in the early 70s in their language program. With Rebecca Ninham, Lloyd Schuyler, Cecilia Danforth, Flora Skenandore. I sat with about seven elders to learn the language. I have a basic foundation and so it's not that I don't understand the need and the crisis that the Tribe is in. I fully understand that and I fully support the efforts to do things around language. But I don't support the manner in which it's being brought in front of us as a procedural exception, three days before the event, and not enough planning and thought going into this project so that it doesn't have to be here like this. I don't think that's taking care of—one, the needs of the program, and two, the needs of the community and us, as a government, having to sit here and make these decisions. I understand what Leander says. I understand what Leander does and I support that. But I don't support the manner in which it continues to come in front of us. Thank you.
