## BC RESOLUTION 09-26-12-E Self-Governance Multi-Year Funding Agreement

WHEREAS,

the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government, a Treaty Tribe recognized by the laws of the United States, and a Self-Governance Tribe with the Department of the Interior's Bureau of Indian Affairs and with the Department of Health and Human Services' Indian Health Service, and

WHEREAS.

the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS.

the Oneida Business Committee has been delegated authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS.

it is the mission of the Oneida Tribe of Indians of Wisconsin to protect and improve the resources, the standards of living, and the environment in which the Oneida people live while maintaining, enforcing, and exercising the sovereign rights of the Oneida Nation, and

WHEREAS,

the Oneida Business Committee has determined that entering into a multi-year Self-Governance Funding Agreement with the U.S. Government's Department of Health and Human Services' Indian Health Service pursuant to P.L. 93-638, as amended, supports and enhances the Oneida Tribe's sovereignty.

NOW, THEREFORE, BE IT RESOLVED that the Oneida Tribe of Indians of Wisconsin approves the Multi-Year Funding Agreement (MYFA) negotiated with the Department of Health and Human Services' Indian Health Service for the period FY 2013 through FY 2016 and authorizes the Chairman to sign the MYFA and Buy-Back/Withhold Agreement for FY 2013 as negotiated.

**BE IT FURTHER RESOLVED** that the Oneida Tribe of Indians of Wisconsin recognizes there will be changes in the amount of funding received pursuant to the MYFA for FY 2014, FY 2015 and FY 2016 and authorizes the Chairman to sign the FY 2014, 2015 and 2016 Amendments and Buy-Back/Withhold Agreements which will be required to receive funding under the MYFA for those fiscal years.
