Minutes of meeting held by Executive Committee

Minutes

Meeting called to order at CCC Camp by Julius Danforth on Monday 8:00 p.m.

Secretary gave report of Sept. meeting. Motion made by Irene Moore to approve minutes of meeting, seconded by Althea Schuyler. Carried.

Treasurers report read as follows:

Rehab. Fund: \$159.00

Tribal Fund: \$ 16.76

Motion made by Eva Danforth to approve Treasurers report, seconded by Irene Moore. Carried.

Council discussed the loan application for Thomas Schuyler Sr. that was approved in Sept. and it was brought up that the council had overlooked the fact that they had agreed not to grant loans in excess of \$800.00 Loan of \$1,500.

Motion was made by Eva Danforth to advise Mr. Thomas Schuyler of this, that his loan would be reduced to \$800. Motion seconded by Irene Moore. Carried.

Council signed lease agreement on behalf of the Tribe and Mrs. Irwin Cottrell. (Property formerly belonging to Daniel Skenandore). Motion was made by Irene Moore, seconded by Eva Danforth to sign these papers. Motion carried.

Council discussed a possible timber sale on the 70 acres of land formerly allotted to Lomis Skenandore. Motion made by Eva Danforth to request the Ashland Agency to make the timber sale, seconded by Irene Moore. Carried.

Motion made by Eva Danforth to revoke the land assignment of Leander Danforth due to the fact that he now has taxable property, seconded by Irene Moore. Carried.

Council discussed a land application for Mrs. David Thomas, formerly Claudette Schuyler, and decided to table it.

Council discussed the land assignment of Earl Cornelius, formerly Charles B. Cornelius assignment, as he refused to sign a standard land assignment and also signed a statement to the effect that he wanted to return the land back to the Tribe. Council decided to consult the Ashland Agency about his as there is personal property involved.

Council discussed the possibility of assigning 1 acre more or less of Joslin Skenandore's assignment (that triangle across the road). James Schuyler was advised to contact Rudolph Webster and see if this would be satisfactory with im.

Motion made by Irene Moore to approve the certificates, seconded by Eva Danforth. Carried.

A land application for Cornelius Baird was presented. Motion made by Irene Moore to approve the application, seconded by Althea Schuyler. Carried.

Motion made by Irene Moore to pay Oscar Archiquette the sum of \$10.00 to cover expenses on trip to Milwaukee in regards to getting names and addresses for annuity roll, seconded by Althea Schuyler. Carried.

Motion made by Irene Moore to allow the Treasurer ½ or 50 cents out of the \$1.00 registration fee for enrollment to compensate her for the extra work and time she has to apply to this, seconded by Eva Danforth. Carried.

Motion made by Irene Moore to give Alexander Denny permission to tear down his old house and use the lumber to build on to the new house, seconded by Eva Danforth. Carried.

Motion by Eva Danforth to adjourn, seconded by Irene Moore. Carried.
