Treasurer reported that Patricia Harmes, daughter of Richard Metoxen is not on the Tribal roll so the Secretary was advised to notify Mrs. Harms of this and inform her that Council will hold the certificates of her children, Joan Mayer, Sandra Mae Harmes, Diana Harmes and Lester William Harmes Jr. until we receive her certificate for enrollment.
