## RESOLUTION # 10-6-93-D

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, to manage all the economic affairs and enterprises of the Oneida Tribe, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Don Hill Property Parcel I Lots one (1), two (2) and three (3), volume 28 certified survey maps, page 253, said map being part of Indian Claim 174, Town of Hobart, Brown County, Wisconsin. Parcel II Those parts of Indian Claim 174 Township 24 North of Range 19 East in the Town of Hobart, Brown County, Wisconsin, described as follows:

That part of Claim 174, beginning at the southeast corner of tract conveyed to Christine Hill by deed dated April 12, 1913 on the line of the Green Bay & Western Railroad; thence N 59° W 657.92 feet to the quarter section Line; thence S 80.41 feet; thence S 59° E 606.07 feet to the right-of-way of the Green Bay & Western Railroad; thence N 39° 38' 4" E 69.63 feet to the place of beginning. Also; The South 2 acres of the following premises, beginning at the South corner of that

The South 2 acres of the following premises, beginning at the south corner of that part of Claim 174, Township 24, Range 19 East, lying North and West of the right-ofway of the Green Bay & Western Railroad at a stake in the right-of-way of said railroad; thence N 59° W 489 feet to the West line of said Claim 174; thence N along said line 339.9 feet to a stake; thence S 59° E 706 feet to a stake in the right-ofway of the Green Bay & Western Railroad; thence S 39° 38' 4" W along said right-ofway to the place of beginning; excepting from the above described parcels, part heretofore conveyed for highway purposes and also excepting therefrom any part thereof that falls within volume 28 certified survey maps, page 253. Property Address: 240 Riverdale Drive Oneida, WI 54155

WHEREAS, the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and

- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and
- NOW, THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcel in trust for the Oneida Tribe of Indians of Wisconsin.
