DISSOLUTION OF ONEIDA AIRPORT BUSINESS DEVELOPMENT CORPORATION

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America, and
- WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, Article IV, Section 1 (h) authorizes the Oneida Business Committee "to charter subordinate organizations for economic purposes", and
- WHEREAS, the Oneida Business Committee granted a Corporate Charter to the Oneida Airport Business Development Corporation ("Corporation") on August 25, 1993 and amended said Charter on March 11, 1994, and
- WHEREAS, the Oneida Business Committee and the Oneida Airport Business Development Board of Directors desire to dissolve the Corporation pursuant to the Corporate Charter of the Oneida Airport Business Development Corporation, Articles XIII(A) and XIII(B), and
- WHEREAS, the Corporation has assigned its lease and amendments to Oneida Seven Generations Corporation, has no creditor claims against it, and is ready to turn over its assets, property and documents to the Oneida Nation.

NOW THEREFORE BE IT RESOLVED, that the Corporate Charter granted to Oneida Business Committee hereby revoked, and that the Corporation is hereby dissolved as of the date of this resolution.

BE IT FURTHER RESOLVED, that the Corporation is directed to close all Corporate bank accounts and forward assets, including any office equipment supplies, etc., to the Tribal Treasurer and forward Corporate documents, including, minutes, corporate book, etc., to the custody of Tribal Secretary.
