## Resolution 10-21-98-B

## 1999 N.I.G.A. Membership Dues

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin and

WHEREAS, the Onieda Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the National Indian Gaming Association (NIGA) is a volunteery association composed of member Tribes and Associate members representing federally recognized Tribal governments, gaming Tribes, Rancherias, Bands and Businesses engaged in gaming enterprises in Indian Country; and

WHEREAS, the primary objectives and purpose of NIGA are:

- 1) to promote, protect and preserve the general welfare and interest of Indian gaming Tribes through the development of sound policies and practices with respect to the conduct of gaming activities in Indian Country.
- 2) to assist in the dissemination of information to the Indian gaming community federal government and the general public on issues related to the conduct of gaming in Indian Country;
- 3) to preserve and protect the integrity of gaming in Indian Country, and
- 4) to maintain, protect and advocate Indian Tribal sovereignty, now

THEREFORE BE IT RESOLVED, the Oneida Business Committee, authorizes the payment of dues for NIGA membership of \$10,000.00; and

BE IT FURTHER RESOLVED, that the Oneida Business Committee hereby appoints <u>Deborah Doxtator</u> as the Tribe/Nation's representative to NIGA, with <u>Gary Jordan, Ernie Stevens, Jr., Rick Hill</u> as alternate (s);

**BE IT FURTHER RESOLVED,** that alternate Rick Hill will abstain from voting on the policy matters pertaining to N.I.G.A. and,

BE IT FINALLY RESOLVED, that their appointments will remain in effect for 1999 and/or until replaced by the Oneida Business Committee.
