## **BC Resolution 10-28-14-C Amending Implementation Date in Resolution # BC-4-25-14-B Which Adopted the Rules of Appellate Procedure**

- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS,** the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Business Committee, as directed in resolution # GTC-01-07-13-B which adopted the Judiciary law and the transition plan, has adopted Rules of Appellate Procedure for the new Judiciary; and
- WHEREAS,** the Rules of Appellate Procedure were adopted by resolution # BC-4-25-14-B which implemented the new rules on November 1, 2014 which coincided with the opening of the new Judiciary; and
- WHEREAS,** the Oneida Business Committee, upon receipt of a request by Chief Appellate Judge Gerald L. Hill and Chief Trial Court Judge Denice Beans, has adopted a resolution amending the transition and opening of the new Judiciary which would also require amending the implementation date of the Rules of Appellate Procedure:

**NOW THEREFORE BE IT RESOLVED,** that the Oneida Business Committee does hereby amend resolution # BC-4-25-14-B to move the implementation date from November 1, 2014 to January 5, 2015.
