RESOLUTION # 10-29-08-A

Adoption of the Official Tribal Zoning Map


- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty Tribe organized under the laws of the United States of America; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida General Tribal Council has delegated the authorities of Article IV of the Oneida Tribal Constitution to the Oneida Business Committee; and
- WHEREAS,** the Tribe and individual tribal members hold fee title to land within the exterior boundaries of the Oneida Reservation (hereinafter referred to as "tribal fee lands") and the United States holds lands in trust for the benefit of the Tribe and for individual tribal members (hereinafter referred to as "tribal trust lands"); and
- WHEREAS,** the Business Committee adopted the Oneida Zoning Ordinance through Business Committee Resolution # 9-28-90-E, the Shoreland Protection Ordinance through Business Committee Resolution # 12-7-81, consolidated the two laws into the Zoning and Shoreland Protection Ordinance through Business Committee Resolution # BC-9-28-90-E, and has from time to time amended the Ordinance; and
- WHEREAS,** the purpose of the Zoning and Shoreland Protection Ordinance is to promote and protect the public health, safety, peace, prosperity, comfort, and general welfare of residents of the Oneida Reservation; assist in guiding the future development of the Reservation in accordance with a Comprehensive Plan, and a Land Use Plan; to protect the character and stability of residential, commercial, industrial, agricultural, and other areas within the Oneida Reservation; and assure the orderly and beneficial development of such areas; and
- WHEREAS,** the Tribe has expended significant resources over the past several decades adopting, implementing and updating a Comprehensive Plan and a Land Use Plan; and
- WHEREAS,** the Business Committee adopted Oneida Real Property Law through Business Committee Resolution # 5-29-96-A and amended the law through Business Committee Resolution # 3-01-06; and
- WHEREAS,** the purpose of Oneida Real Property Law is to provide regulations and procedures for the control and management of tribal fee lands and tribal trust lands; and
- WHEREAS,** the provisions of the Zoning and Shoreland Protection Ordinance and Oneida Real Property Law extend to tribal fee lands and tribal trust lands; and
- WHEREAS,** the Oneida Real Property Law vests the Oneida Land Commission with the authority to implement and interpret the provisions of Oneida Real Property Law; and

- WHEREAS,** the Oneida Land Commission adopted Standard Operating Procedures and pursuant to such procedures approves specific land uses for Tribal trust and Tribal fee lands; and
- WHEREAS,** the Land Use Technical Unit (LUTU) assists the Land Commission in implementing the Standard Operating Procedures by evaluating the environmental buffers and culturally sensitive areas to determine appropriate land uses; and
- WHEREAS,** the Zoning and Shoreland Protection Ordinance authorizes the Business Committee to adopt an Official Tribal Zoning Map; and
- WHEREAS,** the Oneida Business Committee finds that adopting the attached Official Tribal Zoning Map will complement the Tribe's long standing efforts in land use planning and will further the purposes of the Zoning and Shoreland Protection Ordinance and the Oneida Real Property Law; and
- WHEREAS,** pursuant to the Zoning and Shoreland Protection Ordinance, the land use designations of the attached Official Tribal Zoning Map will be applicable only to the Tribe, tribal members and individuals and businesses leasing, occupying or otherwise using tribal fee lands and tribal trust lands.

NOW THEREFORE BE IT RESOLVED, the Business Committee hereby adopts the attached Official Tribal Zoning Map.

CERTIFICATION

I, the undersigned, as Secretary of the Oneida Business Committee, hereby certify that the Oneida Business Committee is composed of 9 members of whom 5 members constitute a quorum. 7 members were present at a meeting duly called, noticed and held on the 29th day of Oct, 2008; that the foregoing resolution was duly adopted at such meeting by a vote of 6 members for; 0 members against, and 0 members not voting; and that said resolution has not been rescinded or amended in any way.
