WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin currently owns several automobiles and needs to purchase additional vehicles for its fleet, and

WHEREAS, Randall Archiquette, in his capacity as fleet manager for the Oneida Tribe, requires authorization from the Oneida Business Committee to negotiate, procure and execute agreements for the sale and/or lease of said vehicles,

NOW THEREFORE LET IT BE RESOLVED THAT Randall Archiquette, in his capacity as Fleet Manager, is authorized for, on behalf of, and in the name of the Oneida Tribe of Indians of Wisconsin to negotiate, procure and execute such agreements with General Motors Acceptance Corporation which are in his opinion necessary or advisable to effectuate the most favorable terms of the Tribe, and the execution of such agreements by said Mr. Archiquette shall be conclusive evidence of his approval thereof.
