



RESOLUTION # 11-17-93-I

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, to manage all the economic affairs and enterprises of the Oneida Tribe, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: SHAY PROPERTY

A parcel of land located in part of the Southwest 1/4 of the Southwest 1/4of Section Thirty-three (33), Township Twenty-four (24) North, Range Nineteen (19) East, Town of Oneida, Outagamie County, Wisconsin, described as follows: Commencing at the West 1/4 corner of said Section 33; thence South 0" 41'35" East 2,530.00 feet to the Northerly line of the K.G.B. and W Railroad; thence South 89'01'00" East along said Northerly line 649.72 feet to the point of beginning; thence continuing South 89'01'00" East 665.91 feet; thence North 0'32'31" West 261.75 feet; thence North 89'01'00" West, 665.91 feet; thence South 0°32'31" East 261.75 feet to the point of beginning.

No. 907664; Lack, of access to and from subject property disclosed in Warranty Deed executed by and between John Philipsen and Gertrude Philipsen and John C. Van Schyndel and Margaret Van Schyndel; Terms, Conditions, Restrictions and Provisions relating to the use and maintenance of the proposed license for Private Grade Crossing.

- WHEREAS, the Oneida Business Committee certified that the local property taxes will be paid up to Trust placement, and
- NOW THEREFORE, BE IT RESOLVED, THAT THE Oneida Business Committee hereby requests the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcel in Trust for the Oneida Tribe of Indians of Wisconsin.
