WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty
Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the goal of the Oneida Tribe is to protect, maintain, and promote self-sufficiency and self reliance by providing housing options for those Oneida Tribal members who cannot afford it, and

WHEREAS, the Oneida Tribe through the Oneida Housing Development with collaboration of the Oneida Homeless/Transitional Task Force, and with a partnership with the Wisconsin Division of Housing/Local Housing Organization Grant Program, and with Oneida Community input, would like to expand the supply of affordable housing, and

WHEREAS, the Oneida Tribe believes that the Oneida Family will be strengthened by promoting the values of our Oneida Identity by providing housing.

NOW, THEREFORE, BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin-Oneida Housing Development Program, authorizes and submits this grant application to the Wisconsin Division of Housing/Local Housing Organization Grant Program for the purpose of preserving, improving, and expanding the capacity to develop and provide affordable housing opportunities and housing counseling for low-income households.
