Resolution # BC-11-29-00-Q

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the General Tribal Council adopted Resolution #11-04-00-A which approved a per capita payment to each enrolled member of \$750.00, in accordance to the Oneida Per Capita Ordinance, to begin in Fiscal Year 2001, and continue through 2003, and
- WHEREAS, the General Tribal Council Resolution #11-04-00-A also states that the first payment shall be made in February of 2001, and
- WHEREAS, the Oneida Trust Committee is delegated responsibility to manage trust accounts in accordance with the Oneida Per Capita Ordinance, and
- WHEREAS, the Oneida Trust Committee approved the attached Tribal Revenue Allocation Plan on November 28, 2000, and
- WHEREAS, the Indian Gaming Regulatory Act states that net revenues from any Class II and III gaming activities conducted or licensed by any tribe may be used to make per capita payments to members of the tribe only if (1) the tribe has prepared a Plan to allocate revenues to authorized uses and (2) the Plan is approved by the United States Assistant Secretary of the Interior as adequate, and
- WHEREAS, the attached Tribal Revenue Allocation Plan ensures that not more than fifty percent (50%) of the net gaming revenues shall be used for per capita payments to members, and

- WHEREAS, the attached Tribal Revenue Allocation Plan for Fiscal Year 2001 is in compliance with the Indian Gaming Regulatory Act, 25 U.S.C. 2701, et seq. as the Plan demonstrates that the Oneida Tribe is dedicating a significant source of net gaming revenue for economic and governmental purposes.
- NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby approves and adopts the attached Tribal Revenue Allocation Plan for Fiscal Year 2001, and
- BE IT FURTHER RESOLVED, that upon adoption by the Oneida Business Committee, the attached Tribal Revenue Allocation Plan and this resolution shall be presented to the United States Assistant Secretary of the Interior for review and approval according to the Indian Gaming Regulatory Act.
