- WHEREAS the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS the Oneida Tribe has acquired in fee status the following parcel described as: Douglas J. Kuffel and Lori A. Kuffel, 820 Green Ridge Drive, Green Bay, Wi. Tax Parcel Number: 6H-2621
- WHEREAS, the parcel is described as follows: Lot Forty-two (42), according to the recorded Plat of Green Ridge Estates, said plat being all of Lot One (1) and part of Lots Three (3), Four (4), Five (5) and Six (6), Section Thirty (30), Township Twenty-four (24) North, Range Twenty (20) East, in the Fourth Principal Meridian, in the City of Green Bay, West side of Fox River, Brown County, Wisconsin.
- WHEREAS the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee herebyrequests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
