Fee to Trust for the Former Richard J. and Geraldine M. Hallam Property

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe has acquired in fee status the following parcel described as:
Former Richard J. and Geraldine M. Hallam Property at N6748 Ranch Road, and
- WHEREAS,** the parcel is described as follows:
Legal Description: See attachment
Tax Parcel Numbers: 17-0-0785-00, 17-0-0787-00, 17-0-0788-00, and 17-0-0789-00, and
- WHEREAS,** the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing site for agriculture land, and
- WHEREAS,** the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

A parcel of land being all of Government Lot Six (6), all of the Northeast 1/4 of the Southwest 1/4, all of the Southwest 1/4 of the Southwest 1/4, and all of the Northwest 1/4 of the Southwest 1/4, all in Section 10, Township 23 North, Range 18 East of the 4th Principal Meridian, Town of Oneida, Outagamie County, Wisconsin, bounded and described as follows:
