- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Former Nicholas (a/k/a Nick) and Mary Heisdorf Property located on Olson Road, and
- WHEREAS, the parcel is described as follows: Legal Description: See attachment Tax Parcel Number: 17-0-0474-00, and
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing site for agriculture, residential, commercial use, and
