Fee to Trust for the Former Patrick J. and Janet Krohlow Property

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe has acquired in fee status the following parcel described as: Former Patrick J. and Janet Krohlow Property at N7550 East Bodart Court, and
- WHEREAS,** the parcel is described as follows:

Tax Parcel Number: 17-0-0061-01, and
- WHEREAS,** the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an existing site for housing, and
- WHEREAS,** the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

The following land contains 5.71 acres more or less, being more particularly described as:

Part of Government Lot 4 and part of the Southwest 1/4 of the Northeast 1/4 of Section 35, Township 24 North, Range 18 East of the Fourth Principal Meridian, Town of Oneida, Outagamie County, Wisconsin, more fully described as follows:

Commencing at the Northwest corner of Government Lot 3 of said Section 35; thence South $31^{\circ} 57' 24''$ West, along the Westerly line of said Government Lot 3 and Government Lot 4, said Westerly line also being the Westerly line of the Town of Oneida, 2497.99 feet to the Southwest corner of Government Lot 4; thence North $86^{\circ} 03' 34''$ East, along the South line of said Government Lot 4, 642.39 feet to the point of beginning; thence continuing North $86^{\circ} 03' 34''$ East along the South line of said Government Lot 4, 744.23 feet to the East line of said Government Lot 4, said East line also being the West line of said SW-NE; thence North $0^{\circ} 15' 45''$ East along the East line of said Government Lot 4, 174.88 feet; thence North $31^{\circ} 57' 24''$ East, 66.9 feet to a point on the centerline of a proposed street; thence North $58^{\circ} 02' 36''$ West along the centerline of a proposed street, 511.0 feet; thence South $31^{\circ} 57' 24''$ West along the centerline of a proposed street, 329.90 feet to center of a 66.0 feet radius cul-de-sac; thence continuing South $31^{\circ} 57' 24''$ West, 322.17 feet to the point of beginning. Reserving the Northerly 33.0 feet and the Westerly 33.0 feet North of said cul-de-sac and the cul-de-sac for street purposes.
