Discussion was held concerning election board for coming Annual Tribal Election. Council decided to have 3 members on election board as there will only be one polling place. Ch. Julius Denforth appointed Zack Skenandore, Vivian Defoteau, and James Schuyler to serve on board. It was decided to pay \$8.00 per person .
