The meeting was called to order by Norbert Hill, Chrm. At 7:25 p.m.

Motion duly made and second to close October meeting. Carried.

The regular meeting from November was called to order by Chrm. Hill.

Minutes from previous month read. Motion made to accept minutes as read. Second and carried.

Receive \$2.00 from Cornil Skenandore to cover lease fee.

Received \$2.00 from Clayton Cornelius to cover lease fee.

Received from Sadie Danforth \$46.66 interest on Peter Danforth's Rehabilitation loan.

Received from Sadie Danforth \$100.00 on Rehabilitation loan for Peter Danforth.

Sadie Danforth, member of Loan Committee presented two application for leans:

1. Inez Grignon Tabled because insecure source of income
2. Frank E. Skenandore Tabled to find standard land assignment

Read letter in regards to Lillian Wheelock. Submitted \$1.00 and birth certificate to be enrolled previously. She wants to find out if she is enrolled. Treasurer will take care of this matter and give her the information necessary to be enrolled.

Earl Sickles wants to be enrolled. Need more information about father. Mr. Riley to check roll about father Martin Sickles.

Motion was second and approved.

Motion made and second and approved as of November 7, 1966 no bills of any nature are to be incurred by anyone without first receiving prior authorization of Executive Council.

Discussed NCAI Convention in Oklahoma. Read schedule of events to take place.

Motion made and second to pay \$125.00 a piece to three delegates to attend the NCAI Convention the week of Nov. 14-18, 1966. Carried.

Discussed Tribal claim with Mr. Riley. He stated that if the government does not re-appeal, it could take 2 to 3 years for payment per capita if such was authorized because of incomplete rolls of Brothertown and Stockbridge Munsee Tribes.

Discussed industry progress. Handord Olson met with officials of SBA and Bathia. Meeting was very promising but needs more information on Bathia.

Ruth Baird questioned Mr. Riley if road for housing will be completed this year. Answer is no, but will be made useable and completed next spring.

Discussed MDTA. Letter from union stating that they are not in favor of MDTA. Riley says they are sending in a construction engineer to set up mutual help housing program and order materials so start could be made in spring.

Henry Stevens wants children enrolled. Cannot find his name on roll. Mr. Riley to check old rolls at Ashland.

Discussed Melissa Cornelius homesite. No claim to 90 acres of land. It is hiership land. Suggest to get her to move to housing development in Oneida.

Gerald Kurowski interested in tribal land for truck farming. Suggested he make application with Artley Skenandore.

Temporary Treasurer's report read. Move to accept temporary Treasurer's report. Second and approved.

Mr. Riley read letter written by agency to commissioners in regard to voting on new constitution and by-laws, stating that it was not the fault of the Bureau or the Oneida tribe that the election was not a success and asking if they would accept the last election results on the proposed constitution and bylaws.

Motion to continue meeting at a later date. Second and carried.
