Continued Meeting  
Name of Tribe – Oneida Tribe of Indians

The meeting was called to order by Chrm. Purcell Powless at 8:25 p.m. at the Mission Hall.

Council members present: Chrm. Purcell Powless, Vice Chrm. Oscar Archiquette, Sec. Loretta Ellis, Treas. Joycelyn Ninham

Minutes were read and approved.

Discussion on Workable Program. Artley Skenandore is appointed Chrm. Other Chrm. Appointments as follows: Irene Moore – Education, Norbert Hill – Industrial Development Committee, Woodrow Webster – Public Relations

Request was made by Chrm. Powless for secretary to write BIA, Ashland, on status of Land and Finance Committee.

Motion by Loretta Ellis to postpone next monthly meeting to second Monday of September. Second by Joycelyn Ninham. Motion carried.

Two approved land assignments were discussed. Apparently, applications of John Reed and Corneil Skenandore are misplaced or lost.

Oscar Archiquette made motion that the application for Standard Land Assignment of Mrs. Inez M. Grignon be approved. Second by Joycelyn Ninham. Motion carried.

Motion by Oscar Archiquette that the Grant of Standard Land Assignment of Mrs. Inez M. Grignon be approved. Second by Joycelyn Ninham. Motion carried.

Oscar Archiquette stated the function of Land Committee is for the use of any Oneida who would like a Standard Land Assignment. The Land Committee then makes recommendations to the Tribal Executive Committee.

The secretary needs to make a copy of Standard Land Assignment for Sylvester Foster Cornelius. It is suggested Mr. Artley Skenandore draw up a release of 4 acres. Clayton Cornelius will then need to make an application for an additional 1 ½ acres.

In the absence of proper paperwork, Mrs. Irving Metoxen should release 5 acres to the Tribe and application for same be made by Robert Danforth (redeemed land).

Real Estate Planning Report is explained by Oscar Archiquette.

Land Ordinance is read by Joycelyn Ninham.

Motion is made by Joycelyn Ninham to accept following birth certificates, including all names. Second by Oscar Archiquette. Motion carried.

Motion by Oscar Archiquette to revoke Omer Ninham's Standard Land Assignment. Second by Joycelyn Ninham. Motion carried. Revoked 15 August 1967 – notified by letter.

Motion by Oscar Archiquette that Tribe buy typewriter. Second by Joycelyn Ninham. Motion carried.

Oscar Archiquette moves that Executive Council be paid for this continued meeting and treasurer be paid \$24 for birth certificates. Second by Loretta Ellis. Motion carried.

Discussion on delegates to NCAI meeting first week in October in Portland, Oregon and looking into costs of transportation.

Motion by Oscar Archiquette to revoke Standard Land Assignment of Tom Claude Schuyler, Jr. Second by Joycelyn Ninham. Motion carried. Revoked 15 August 1967 – notified by letter.

Motion by Oscar Archiquette to pay electric bill \$530.54 out of Rehab fund to Len's Electric shop, Seymour, Wisconsin. Second by Joycelyn Ninham. Motion carried.

Motion by Oscar Archiquette to continue meeting to a later date. Second by Joycelyn Ninham. Motion carried.
